Your application with a non-refundable application fee of \$75.00 must be submitted on or before the deadline date.

Authors may submit more than one abstract. However, only one abstract will be accepted per primary author/presenter. Number of abstracts may be limited.

ABSTRACT GUIDELINES

- Abstracts must be no longer than one page (400 words or less), with font size 11 or 12 and all margins one inch.
- The content described must be appropriate for a poster presentation.
- Research abstracts must include title and author information.
- Purpose, methodology, results, and implications for NPs must be clearly identified.
- This cover sheet must be completed and included with the abstract.
- The abstract must be accompanied by a 1-2 page biosketch (CVs not accepted).
- Advertising and/or commercial materials may not be distributed.
- Only generic names of drugs and other products may be used in the body of the exhibit/poster.

It is agreed that presenters shall indemnify and hold harmless AANP from all liability, which may ensue from any cause whatsoever. It is recommended that you not place any items of value on display in your booth until your booth personnel are in attendance.

Because AANP accredits the general (non-industry sponsored) posters for CE credit, industry sponsored poster space will be separated (or set apart) from the other posters. Your application and space assignment are subject to acceptance by AANP. However, AANP reserves the right to restrict any scientific exhibit that, in the opinion of AANP, is deemed promotional, commercial or unethical.

SUBMISSION DEADLINE: MUST BE RECEIVED ON OR BEFORE MARCH 15, 2012
