



## **American Academy of Nurse Practitioners Health Policy Internships**

The American Academy of Nurse Practitioners is offering 1 to 3 month internships in conjunction with its Office of Health Policy in Washington. Intern positions may be with the applicant's personal legislators, with positions arranged through the Office of Health Policy in the legislative and executive branches of the federal government, or in the Academy Office of Health Policy. The focus of the internship will be on health policy issues related to nurse practitioners and their patients.

Internships begin with an orientation to the legislative or executive branch of the federal government and conclude with a final discussion and written report to the Office of Health Policy regarding strategies and goals for future. Interns in legislative or administrative offices will be mentored on a weekly basis during the internship. Interns in the Office of Health Policy will be assigned particular issues to monitor and work on during the internship and will be mentored throughout the process.

Interns will be responsible for their own living expenses during the internship. Local travel (such as metro, cab or mileage) conducted for the business of the internship will be reimbursed by the American Academy of Nurse Practitioners.

Applicants must submit an application, resume and statement of goals for review in order to be accepted into the program. Applications will be considered on a case-by-case basis at the time of their receipt.
